- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hour on 6 March, 2020 at the office of Kalimati Rural Municipality Rampur, Salyan.
- 6. Bids must be valid for a period of *90 days* and must be accompanied by a scanned copy of the bid security in .pdf format for e-bid, which shall be valid for 120 days from the final bid submission date. If bidder wishes to submit the bid security in the form of cash the cash should be deposited in the bank account with the following information.
